

Mission Statement	The U.S.-Japan Conference on Cultural and Educational Interchange (CULCON) is a binational advisory panel that serves to elevate and strengthen the vital cultural and educational foundations of the U.S.-Japan relationship, and to strengthen connections between U.S. and Japan leadership in those fields. It works to ensure that the best of new ideas for cultural, educational and intellectual activity and exchange are implemented as operational programs.	The Japan-U.S. Friendship Commission (JUSFC) is an independent federal agency established by Congress in 1975 to strengthen the U.S.-Japan relationship through educational, cultural, and intellectual exchange. Its mission is to support reciprocal people-to-people understanding, and promote partnerships that advance common interests between Japan and the United States. JUSFC accepts grant applications in the following areas: 1. Arts and Culture 2. Education and Public Affairs 3. Exchanges and Scholarship 4. Global Challenges	The U.S.-Japan Bridging Foundation (USJBF) aims to expand the opportunities for study abroad in Japan by granting incentive scholarships to American undergraduate students to help prepare America's young people to assume future global leadership roles. USJBF also engages in other program areas which strengthen the educational and cultural ties between the U.S. and Japan, including public-private partnerships.
